## **Montgomery County Recreation Initiative**

Montgomery County (MC) Government is promoting the health and well-being of qualified employees by encouraging participation in activities that can reduce stress and/or enhance fitness by offering the *Total Rec Pass* for free! The Total Rec Pass is valid for one year and allows access to all Montgomery County Recreation facilities including: indoor and outdoor pools for lap and recreational swimming, and community centers for use of the exercise rooms, game rooms, and open gym activities. Be sure to check out *mocorec.com* for facility operating hours and additional information.

In addition, a 20 percent discount is offered to qualifying employees who purchase an *Annual Family All Pool Pass*. This annual pass allows access to our four indoor pools all year long, and to our seven outdoor pools during the summer months for lap and recreational swimming.

## Who Is Eligible for the individual Total Rec Pass and Annual Family All Pool Pass discount?

- Current MC Government merit employees who are unrepresented;
- Current MC Government members of MCGEO, IAFF, FOP;
- LOSAP active members of MCVFRA; and
- *Permanent* MCPS employees.

## **Registration Information**

- Complete the MCG/MCPS Employee Wellness Pass Application and click Submit. Allow MC up to seven business days to process your application. MC Recreation will send you a registration confirmation receipt once your application is processed. You will need to bring the confirmation receipt, along with a valid photo ID, to any Montgomery County Recreation community center or pool. Facility staff will issue you a Rec Pass card for your use.
- 2. If you don't already have an ActiveMONTGOMERY recreation account, we encourage you to create your account online at ActiveMONTGOMERY. This will reduce application processing time and help get you in the pool or gym faster.
- 3. If you have an existing ActiveMONTGOMERY account, you may already have a Rec Pass card. In this case, the Employee Wellness–Total Rec Pass will be added to your existing Rec Pass card.
- 4. Both the Total Rec Pass and the Annual Family All Pool Pass are valid for one year. Each year, applicants must reapply by completing and submitting a new form.
- 5. The Annual Family All Pool Pass is available at a 20 percent discount to qualified employees and includes the employee, one parent and/or guardian, and up to four single legal dependent children under 21 years of age residing at the same address. An additional fee of \$20 per child is charged for five or more children. Non-county residents must add \$100 for the Annual Family All Pool Pass. There are no refunds for the Family All Pool Pass. To apply for the Family All Pool Pass, complete and submit the Employee Family Pool Pass Application.

The Total Rec Pass and Family All Pool Pass are not transferable. A valid photo ID must be presented on your first visit to the pool or community center. If you have questions regarding the program, please call 240-777-6840 or e-mail Rec.EmployeeWellness@montgomerycountymd.gov.
